A PEP falls into one or more of these categories: • a Politically Exposed Foreign Person (PEFP) holds or has held the position outside Canada • a Politically Exposed Domestic Person (PEDP) holds or has held the position within Canada in the last five years • the Head of an International Organization or an institution established by an international organization⁴ (HIO)							
Definitions: 1 A close relative is a spouse; common-law partner; mother; father; child; brother or half-brother; sister or half-sister; spouse's or common-law partner's mother or father. 2 A close associate is someone other than a family member with whom the PEP has a mutually beneficial relationship, whether for business or personal reasons. 3 This form lists these foreign and domestic positions later in this section. 4 The head of an institution that was established by an international organization, was set up by the governments of more than one country and was formed through a formally-signed agreement between the governments of more than one country. The HIO is the primary person who leads the institution; for example, a president or CEO. This PEP also includes a close relative of the person or close associate of the HIO.
